## GENERAL RELEASE, WAIVER OF RIGHTS AND HOLD HARMLESS AGREEMENT

This General Release ("**Release**") is made on the date of signature between you ("**Releasor**") and Arts of Point Richmond, a nonprofit charitable corporation in Richmond California ("**Releasee**").

1. Releasor and anyone claiming on Releasor's behalf releases and forever discharges Releasee and its affiliates, successors, officers, employees, representatives, partners, agents and anyone claiming through them (collectively, the "Released Parties"), in their individual and/or corporate capacities from any and all claims, liabilities, obligations, promises, agreements, disputes, demands, damages, causes of action of any nature and kind, known or unknown, which Releasor has or ever had or may in the future have against Releasee or any of the Released Parties arising out of or relating to: all AOPR meetings, events and exhibitions whether in public spaces or private homes, whether paid or free, whether in conjunction with other entities or organizations or not, and including both property damage, economic damage and personal harm up to and including death ("Claims"). This general release, waiver of rights and hold harmless agreement specifically includes claims against any and all members of AOPR participating in AOPR events, any and all owners of exhibition venues showing the work of AOPR members and any and all owners of private homes used for AOPR functions, regardless of ordinary negligence on the part of these members and owners.
2. Releasor explicitly acknowledges that this Release, Waiver of Rights and Hold Harmless Agreement applies to harm that may be done to Releasor's artwork, including destruction of or theft of the artwork, displayed in any AOPR activity or exhibition whether inside a venue or outdoors.
3. In exchange for the release of any and all Claims, Releasee will provide Releasor with access to and information about all AOPR activities while Releasor is a paid-up member of AOPR. In consideration of such access and information, Releasor agrees that this consideration is a full and complete settlement and satisfaction of any present and prospective claims, including those filed when Releasor is not a paid-up member of AOPR.
4. This Release shall not be in any way construed as an admission by the Releasee that it has acted wrongfully with respect to Releasor or any other person, that it admits liability or responsibility at any time for any purpose, or that Releasor has any rights whatsoever against the Releasee.
5. This Release shall be binding upon the parties and their respective heirs, administrators, personal representatives, executors, successors and assigns. Releasor has the authority to release the Claims and has not assigned or transferred any Claims to any other party. The provisions of this Release are severable. If any provision is held to be invalid or unenforceable, it shall not affect the validity or enforceability of any other provision. This Release constitutes the entire agreement between the parties and supersedes any and all prior oral or written agreements or understandings between the parties concerning the subject matter of this Release. This Release may not be altered, amended or modified, except by a written document signed by both parties. The terms of this Release shall be governed by and construed in accordance with the laws of the State of California and the venue for any dispute shall be in Contra Costa County.
